
## 1. Background:

The Kanker District which is situated in the southern region of Chhattisgarh has a total area of the district is 7161 square kilometers. The district which does have hilly pockets and the few rivers is situated on the National Highway and lies between Raipur and Jagdalpur. Kanker district is divided into 7 blocks namely Kanker, Charama, Bhanupratappur, Antagarh, Durgukondal, Pakhanjur and Narharpur. The district comprises of 427 Gram Panchayats and 5 Urban areas.
